Dear Parents:

We will once again be offering bus service to and from Long Island, NY due to the high enrollment of campers from the New York area.

COST

The cost of a bus reservation will be **\$185.00** for round trip and **\$115.00** for one-way arrangements.

Bus reservations **after June 15th** will be **\$210.00** for round trip and **\$140.00** for one-way arrangements.

DEADLINE DATE:

All bus reservations and payments must be in by June 15, 2010. Any reservations after that date can not be guaranteed a reservation. There will be no refund in the event of withdrawal unless withdrawal is for medical reasons.

LUGGAGE LIMITATION:

All campers will be limited to 1 standard sized (36"x15") trunk and 1 carry-on bag. There will be no bicycles, stereos, skateboards, etc. allowed on the buses. Cyr Bus Company has informed us that there will be no junk food (i.e. candy, chips, gum, and chocolate) allowed on the bus. Please provide lunch money or a bagged lunch for your child when we stop at the rest area.

DROP OFF/PICK UP:

We will again be using the parking lot at **Holy Trinity High School, 98 Cherry Lane in Hicksville, NY 11801**. The bus will depart from the parking lot (which is off of Newbridge Road) at 7:00 a.m. on the Sunday morning beginning each session. **Please look for CYR buses.** IT IS ESSENTIAL that campers be there 1/2 hour early to load luggage, etc. The bus drivers will not wait for late campers, so please do observe their schedule.

Campers on return trips to Long Island are scheduled to leave the Camps at 9:00 a.m. on Saturday. The bus will be stopping at a rest area along the way to allow the children to get off and eat lunch. With the estimated traveling time the bus company gave us and the 1/2 hour lunch stop, we predict the time of arrival to be between 4:00 and 4:30 p.m. Please note that we cannot control the amount of traffic, so the time of arrival could change by an hour either way. You are welcome to call the Camp office (Fatima, 603-364-5651; Bernadette, 603-569-1692) to inquire as to whether the bus did leave on time.

Please note: To facilitate a speedy departure from Long Island, campers will be loaded on the bus alphabetically by last name. Campers may choose their bus mate on the return trip to Long Island.
